follow a contextualized curriculum which has local culture, traditions and ethos vii. incorporated in it;

viii. registration of trust;

ix. the list of persons in the Management of the trust;

permission, if any, granted by the Director School Education, Jammu for x. running the school upto 5th class;

details of infrastructure, assets etc available with the trust; and XI.

undertakes to follow instructions which the State Government may issue from time to xii, time for ensuring quality education in the State.

xiii. possess infrastructures as prescribed in SRO-123 dated: 18th March, 2010.

posess the drinking water and toilet facility for students and fir extinguisher xiv.

The school shall be open to the inspection by the Director School Education, Jammu or any other officer authorized by the School Education Department.

Further, NOC is granted purely on provisional basis, if the management fail to fulfill the above said conditions within a period of three months NOC granted shall be treated as withdrawn.
