It is to inform that the recognition/Affiliation Committee of the Board at its meeting held on 16<sup>th</sup> of September, 2011 resolved to grant Provisional Affiliation In favour of your institution for running classes upto 12th till ending March 2012 subject to the following condition/s:-


1. that the institution adopts the books in various classes as prescribed by the Board and also places its staff, equipments, halls, rooms, laboratories and other apparatus at the disposal of the Board for the conduct of various examinations.
2. the school shall keep its premises as well as record available at any time for surprise inspection of the Board/School Education Department Team.
3. To provide playground to the students.
4. To pay salary through Cheque system.

Deficiencies as pointed out above shall be removed by the institution concerned and compliance reported through principal of the concerned institute duly countersigned by the President/chairman of the School/Trust/Management within six months from the date of issuance of this letter and need to complete all other conditions in respect of physical infrastructure within one year.

In case conditions are not fulfilled within stipulated period, the Board shall be at liberty to impose a fine up to the limit of Rs. 50,000 or cancel the recognition/affiliation of the institution or both.

Further recognition/affiliation for longer period shall only be considered when provisions of SRO 123 are met fully and Higher Academic standard are maintained consistently.
